### Bylaws

#### Article I – Name

The name of the organization shall be AzHOSA, (Insert your school name) Chapter.

#### Article II – Purpose

**Article VI – Meetings**

Section 1. One business meeting shall be held each month during the school year.

All proposed amendments must be submitted by the AzHOSA to the chartered Chapters at least thirty days prior to the regular meeting.

**ARTICLE IX - PARLIAMENTARY AUTHORITY**

The rules contained in the current edition of Robert's Rules of Order, Newly Revised, shall govern the organization in all cases to which they are applicable and in which they are not inconsistent with these Bylaws, the Bylaws or corporate charter of HOSA, Inc. and any special rules the organization may adopt.
