Bylaws

Article I – Name

The name of the organization shall be AzHOSA, San Carlos Secondary School Chapter.

Article II – Purpose

The purposes of this organization are:

1. To create more interest and understanding in the intelligent choice of a healthcare career.
2. To unite in a common bond without regard to race, creed or national origin student enrolled in (name of class)

Article III – Organization

Article V – Officers

- Section 4. Vacancies on the officer team shall be filled at the by the advisor and/or officer team.

Article VI – Meetings

- Section 1. One business meeting shall be held each month during the school year.
- Section 2. Additional meeting shall be called when necessary
- Section 3. The officer team shall meet prior to each monthly meeting at the time specified by the President and Advisor.

Article VII – Committees

- Section 1. Committees of the San Carlos HOSA organization shall consist of the following: HOSA Activities, and should reflect the needs of the chapter)
- Section 2. The Chairman of the committees shall be appointed by the officer team and approved by the membership.

ARTICLE VIII - AMENDMENTS

These Bylaws may be amended by a two-thirds vote at any regular chapter meeting, provided the amendment has been proposed by the officer team or any chapter member. Proposed amendments must be submitted in writing at least 60 days before the next regular meeting. All proposed amendments must be submitted by the AzHOSA to the chartered Chapters at least thirty days prior to the regular meeting.

ARTICLE IX - PARLIAMENTARY AUTHORITY

The rules contained in the current edition of Robert's Rules of Order, Newly Revised, shall govern the organization in all cases to which they are applicable and in which they are not inconsistent with these Bylaws, the Bylaws or corporate charter of HOSA, Inc. and any special rules the organization may adopt.
