This is a new PILOT event **only offered in selected states**. This event will NOT be offered in official competitive capacity at ILC 2025; however there may be opportunity for participants to take part in an event demonstration at ILC. Editorial updates made to rubric on 12/4/2024.

Event Summary

The Surgical Technology event allows members to gain essential knowledge and skills required for the field of Surgical Technology. This competitive event consists of two rounds. Competitors will explore the Certified Surgical Technologist (CST) career path through an interview, research, and a presentation to judges. Top-scoring competitors will advance to Round Two for a clinical skills assessment. This event aims to inspire members to learn more about Surgical Technology careers, enhance critical thinking skills, and prepare to become allied health professionals capable of effectively assisting in surgical settings.

Dress Code

Bonus points will be awarded for proper dress.

Round 1: Proper business attire, official HOSA uniform, or attire appropriate to the occupational area Round 2: Attire appropriate to the occupational area (Surgical Scrubs)

Competitors Must Provide:

- A photo ID for both rounds
- Sterile Surgical Gloves (x2), surgical cap or bouffant cap, surgical gown, shoe coverings, mask, goggles, safety glasses, eye shield, or face guard and surgical scrub brush (no soap).
- Index cards or electronic notecards (optional)
- Any battery-operated device and presentation aids/tools needed to support the Round One presentation

- 3. Competitors will select a Certified Surgical Technologist who is familiar with their chosen topic from the list provided from item #7.
- Competitors will conduct an interview with their selected Certified Surgical Technologist and ask
 questions to help them learn more about the career and the topic they selected for their
 presentation.

Round One Presentation Content

- 7. The eight (8) minute presentation for judges will include:
 - a. Overview of Certified Surgical Technologist Careers
 - i. Demand and Occupational Outlook
 - Research the need for CSTs and why now is the time to consider this career path
 - ii. Educational pathways and requirements
 - Educational pathways and requirements to become a Certified Surgical Technologist, including opportunities for advancement through specialty certifications.
 - iii. Overview of the profession
 - Explanation of the Certified Surgical Technologist's role within surgical teams, the benefits and challenges of the profession, and the various healthcare settings in which they operate.
 - b. Competitors will also conduct research relevant to ONE of the selected topics below: (competitors will select ONE topic)
 - i. Surgical Techniques and Procedures
 - Discuss the role of a Certified Surgical Technologist in specific surgical procedures.
 - ii. Infection Control in the Operating Room
 - Explain the importance of infection prevention and aseptic technique in a surgical setting.
 - iii. Patient Safety and Advocacy
 - Outline how Certified Surgical Technologists contribute to patient safety and advocacy during procedures.

Round One: Presentation Details

- 8. Competitors will create an educational and creative presentation "How Does a Certified Surgical Technologist Play a Role in ______(insert selected topic from item #7)" that will be shared with judges during the competition. The exact presentation title can be of the competitor's choosing.
- 9. The presentation will be a maximum of eight (8) minutes long.

- 10. Competitors may use any presentation aids/tools/technology they wish Prezi, PowerPoint, Bulb, video clips, videos, photos, posters, handouts, etc. –. Still, the competitors must speak during the presentation and only use the aids to enhance the message they are trying to convey. In other words, competitors should not simply record something ahead of time and push "play" the presentation should be live for the judges.
- 11. Competitors should present the content creatively to capture the judges' attention and share what they learned about the Certified Surgical Technologist as it relates to their chosen topic.
- 12. The content can be organized and presented in any manner the competitor wishes the most compelling and unique ways of sharing the content will be most successful.
- 13. Regional and/or State Leadership Conference (SLC) Demo Process for Round One Presentation
 - A. Since Surgical Technology is considered a Pilot Event for 2024-2025, State Advisors will determine if the Round One: Presentation will be conducted and judged in-person or submitted to the HOSA Digital Upload System for Pre-Judging.
 - B. It is the competitor's responsibility to check with their Local Advisor for all state-level processes used for competition as digital uploads may or may not be a requirement.
 - a. In-Person Option: Review Steps 14-18 below
 - b. Digital Upload/Pre-Judging Option: Review Steps 19-24 below

Round One: Presentation Competitive Process (In-Person Option)

- 14. Competitors will report to the event site at their appointed time with any pre-made presentation aids/tools/technology to support their presentation. HOSA only provides one table. The competitor must provide any other equipment and presentation needs.
- 15. Upon entering the competition room, competitors will have two (2) minutes to set up any presentation equipment/materials.
- 16. Competitors will NOT have access to electricity. A personal electronic device (such as a laptop) is permitted. Internet connection is NOT provided but can be used if provided by the competitor via a Wi-Fi hotspot or other source.
- 17. The use of index card notes during the presentation is permitted. Electronic notecards (on a tablet, smartphone, laptop, etc.) are permitted, but they may not be shown to the judges.
- 18. The timekeeper will announce when the two (2) minute setup time is complete and when one (1) minute remains in the presentation. The timekeeper will stop the presentation after eight (8) minutes, and the competitor will be excused.

Round One: Presentation Competitive Process (Digital Upload Option)

- 19. The Presentation must be saved with a link viewable by anyone and uploaded to the HOSA Digital Upload System as explained below.
- 20. The following item(s) **MUST** be uploaded to the HOSA Digital Upload System by the date determined by the State Advisor
 - A. Link to the Round One Presentation
- 21. The date determined by the State Advisor is considered the **final deadline** and there will be **NO EXCEPTIONS** for receipt of the required materials after the deadline.

- 23. We STRONGLY suggest not waiting until the last minute to upload online to avoid user-challenges with the system.

24. The digital materials uploaded will be PRE-JUDGED. Competitors who do not upload materials are NOT eligible for the Round Two skill portion of competition. All digital content uploaded is what will be used for pre-judging.

Advancing from Round One to Round Two

25. The presentation score from Round One will be used to qualify the competitor for Round Two.

- 28. The selected skill(s) will be presented to competitors as a written scenario at the beginning of the round. The scenario will be the same for each competitor. Some scenarios may involve the combination of multiple skill sheets, in which case some elements may not be scored due either to being duplicative or not appropriate within the scenario. A sample scenario can be found here.
- 29. Timing will begin when the scenario is presented to the competitor and will be stopped at the end of the time allowed.
- 30. The scenario is a secret topic for the skill(s) to be performed. Competitors MAY NOT discuss or reveal the secret topic until after the event has concluded or will face penalties per the GRRs.
- 31. Judges will provide information to competitors as directed by the rating sheets. Competitors may ask questions of the judges while performing skills if the questions relate to the patient's condition and will be included in the scenario or judge script.

Final Scoring

- 32. The competitor must earn a score of 70% or higher on the combined skill(s) of the event to be recognized as an award winner at the ILC.
- 33. The final rank is determined by adding the round one presentation score plus the round two skill score. In case of a tie, the highest presentation score will be used to determine the rank.
