Code of Conduct

A good reputation enables members to take pride in their organization. HOSA members have an excellent reputation and will not allow any event attendee to compromise this reputation. All attendees at any HOSA function should make a positive contribution to the reputation that has been established.

1. Your behavior at all times should **positively** reflect you, your school, state and HOSA.
2. Supervision and student conduct is the responsibility of the local chapter advisor. Students shall always keep their advisors informed of their activities and whereabouts. (HOSA conference name badges shall always be worn within the event space.)
3. Participants are expected to attend all general sessions and other scheduled conference activities. Please be prompt and show respect to those in the audience and on stage.
4. Members are to report any incidents, injuries, or illness to their local or state advisor immediately.
5. Members are expected to observe the designated curfew. (Curfew is defined as being **QUIETLY** in your **OWN** assigned room by the designated hour.)
6. If a student is responsible for stealing or vandalism, the student and his/her parents will be expected to pay any and all damages.
7. Participants attending any HOSA Conference, or conference-related activity may not purchase, consume, or be under the influence of alcohol or drugs at any time. Violators will be subject to disciplinary action. This includes being sent home at their parent's expense.
8. Smoking (including vape pens) or using tobacco products at a HOSA-related or school-sanctioned activity on or off school or event property is strictly prohibited.
9. Students who disregard the rules will be subject to disciplinary action and will be sent home at their own expense. Parents will be notified by their local advisor.
10. Any long-distance phone calls, charges to the room, etc., will be the responsibility of the individual student and/or their parents.
11. Participants will abide by the HOSA Conference Dress Code Policy at all business sessions, general sessions, competitive events, and other conference activities.

A student in violation of this Code of Conduct may be disqualified and sent home at his or her family's expense and membership may be revoked. If the student is an officer, a violation may result in removal from office. If the student is sent home, all measures will be used to secure a safe and financially sound method of travel home. If an advisor is found to be in violation of the Code of Conduct, they may be asked to leave a HOSA event and replaced for supervisory reasons by another member of the staff at the school's expense. That advisor's supervisor will also be notified of the violation. Both students and advisors are also expected to follow any and all policies set forth by their own school/district, and subject to the disciplinary policies there in addition to any actions listed above.
